ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the application was submitted for grant of recognition for B.Ed. course in the name of institution "Matoshri Education Society's Satyajeet B.Ed. College, Mehkar, Tq. Mehkar, Dist. Buldana, Matoshri Education Society, "Matoshri" Shivaji Nagar, At Po. & Tq. Mehkar, District- Buldana, Maharashtra, Pin Code- 443301 to WRC, NCTE.

AND WHEREAS, recognition was granted by WRC, NCTE in the name of Matoshri Education Society, Mehkar, Akola Highway, Ta. Khandala Tq. Mehkar, Dist- Buldana, Maharashtra by WRC, NCTE for B.ED (MARATHI)(Co-ed) Course of one year duration with an annual intake of 100 students vide order No. WRC/5-6/96/2007/C-18914 dated 06.07.2007.

2. AND WHEREAS, after promulgation of NCTE Regulations, 2014, the revised order was issued vide No. WRC/APW03994/123476/2015/136557,577,580,584,587,589,590,591 dated 25.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students (two basic units of 50 students each) from the academic session 2015-16.

3. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order was considered by WRC in its 255th meeting held on June 22-24, 2016 and the Committee decided that show cause notice be issued to all such institutions which have not submitted compliance. Accordingly, show cause notice was issued to the institution dated 08.03.2017.

4. AND WHEREAS, the institution requested vide letter dated 10.03.2022 received on 06.04.2022 regarding reduction of B.Ed. intake from 100 to 50 and the matter was considered by WRC in its 364th meeting held on 15th to 17th June, 2022 and the Committee decided as under:

"The original file of the Institution along-with other related documents were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee observed as under:

- Revised recognition order was issued to the institution of 100 students (two basic unit of 50 students each) to the institution vide order dt. 25.5.2015.
- Institution vide its letter dt. 10.3.2022 has requested for reduction of intake from 100 (two units) to 50 (one unit).
- Institution has submitted all requisite documents for reduction of intake.

In view of the above, Committee accepted the request and permitted to reduce the intake from 100 (two units) to 50 (one unit)."



Mehkar, Dist- Buldana, Maharashtra reducing the annual intake of B.Ed. course from 100 students (two basic units of 50 students each) to 50 students (one unit of 50 students) in light of NCTE Regulations, 2014.

The terms and conditions shall remain same as mentioned in the revised recognition order issued dated 25.05.2015.




